Law School Scholarship

- For a law student attending an accredited law school who personally (or a family member) was the victim of a major accident. Entrants must submit a 1-3 page essay describing the impact that the accident had on them (or the family member).
- Academic achievement demonstrated through a cumulative minimum GPA of 3.0 from undergraduate or being in the top 33% of the law school class.

University Scholarship

- For a student attending an accredited university who personally (or a family member) was the victim of a major accident. Entrants must submit a 1-3 page essay describing the impact that the accident had on them (or the family member).
- Applicant must be a U.S. citizen and 18 years or older.
- Full time students who have academic achievement demonstrated through a cumulative minimum GPA of 3.0 from undergraduate.

Essay Instructions:

Please submit a one to three (1-3) page typed essay describing the impact that the accident had on you (or your family member) with your application.

Award:

- Scholarship is to be used exclusively for law school/university tuition and related academic expenses.
- A check for \$1,000 will be made payable to the award recipient's school to cover these expenses.
- The two winners will be notified on or about June 30th, 2016.
